

1. That the sponsoring Society/Trust/Company shall provide adequate funds for the development of land and for providing related infrastructural, instructional, and other facilities as per norms and standards laid down by the Kazi Nazrul University and Bar Council of India, for the sake of brevity “KNU” and “BCI” respectively, from time to time and to meet recurring expenditure.
2. That the College/Institution/Centre shall have to be managed by the Governing Body duly constituted in accordance with the provisions as prescribed by Govt. of W.B./ UGC/KNU from time to time.
3. That the admission and conduct of courses shall be made in accordance with the regulations notified by the Govt. of W.B., KNU, and BCI from time to time.
4. That the curriculum of the program, the procedure for evaluation/assessment of students, and the infrastructure in the classrooms, laboratories & library shall be in accordance with the norms prescribed by the KNU, and BCI.
5. That the College/Institution/Centre shall not allow closure of the College/Institution/Centre, discontinuation of the program(s), or the start of any new program(s) and any change in intake capacity of seats without the prior approval of the KNU, and/or BCI.

6. That no excess admission shall be made by the College/Institution/Centre over and above the approved intake under any circumstances. In case any excess admission is reported to / found by the KNU, appropriate penal action including withdrawal of affiliation shall be initiated against the College/Institution/Centre.
7. That the College/Institution/Centre shall not conduct any program(s) in the field of legal education or non-legal education in the same premises/campus and/or in the name of the College/Institution/Centre without prior permission/approval of KNU and BCI. In case any violation is reported to/found by the KNU, appropriate penal action including withdrawal of affiliation shall be initiated against the College/Institution/Centre.
8. That the College/Institution/Centre shall operate only from the approved location, and the Institution shall not open any off-campus study centre/extension centre directly or in collaboration with any other Institution / University / Organisation for the purpose of imparting legal education without obtaining prior approval from the KNU and BCI.
9. That the accounts of the College/Institution/Centre shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the KNU.
10. That the College/Institution/Centre shall furnish requisite returns & reports as desired by KNU in order to ensure proper maintenance of administrative & academic standards.
11. That the Director / Principal and the teaching staff, and non-teaching staff shall be selected according to procedures, qualifications, and experience prescribed by the KNU / BCI / UGC from time to time, and pay scales and other allowances & benefits shall be as per the norms prescribed by the Govt. of W.B. / UGC / BCI from time to time.
12. That if the College/Institution/Centre fails to disclose the information or suppress and/or misrepresent the information, appropriate action could be initiated including withdrawal of KNU affiliation.
13. That the College/Institution/Centre shall be inspected by KNU ordinarily once a year and may carry out random inspections round the year for verifying the status of the Institutions to ensure maintenance of norms and standards prescribed by KNU. Deficiencies / Shortcomings if any as were/will be pointed out shall have to be removed within a reasonable time to be prescribed by KNU, failing which penal action including withdrawal of affiliation shall be initiated against the College/Institution/Centre.
14. That the KNU may also conduct inspections with or without notifying the dates to verify specific complaints of misrepresentation, violation of norms and standards, malpractices, etc. Adverse findings will lead to appropriate penal action including withdrawal of affiliation.
15. That the College/Institution/Centre shall take appropriate measures for the prevention of ragging in any form, in the light of directions of the Supreme Court of India in Writ Petition (civil) 656 of 1998 and norms as stipulated by the UGC and BCI.

In the event of the closure of the College/Institution/Centre, the Organizing Society / Trust will not close the College/Institution/Centre till the last batch of students admitted to the academic program(s) complete the total duration of their respective academic program(s) (i.e., 3 years, 5 years, etc. as the case may be).


18. That the KNU will have no financial liability whatsoever for conducting the program(s).
